

2022 WN Anti-Doping Report

Education

In 2022 WN piloted its education plan by ensuring that athletes from 2 regions received education relating to their rights and responsibilities prior to competing at WN events. This education was mainly conducted using NADO training resources and WADA's Anti-Doping Education and Learning (ADEL) Platform. In 2022 WN focused on athletes attending Netball World Cup 2023 (NWC2023) Qualifiers for Europe and Asia regions.

In 2023, WN will shift to ensure that all athletes participating in NWC2023 receive education prior to competing, and work with partners to implement an awareness campaign at NWC2023.

Therapeutic Use Exemptions (TUES)

WN welcomed new members to its TUE Committee (TUEC) in 2022. The TUEC can also call on experts from outside the TUEC for guidance should the need arise regarding any specific TUE application.
