1. CURRICULUM VITAE

Background

Dr. Patricia Butcher is a dedicated professional with over forty (40) years of extensive and proven experience in a wide range of disciplines including Human Resource Management, Administration, Strategic Planning, Marketing Operations, Customer Service, Education, Finance and Managerial Accounting. Of note, she has functioned in the Education, Energy, Airline, Hospitality and Tourism and Sport environments.

Dr. Butcher is supported by a close knit sporting family whose experience includes participation in sporting disciplines, notably netball and football at the player and administration levels. In addition, they have functioned at the



highest levels in sectors with a focus on national policy formulation, sport administration, law and corporate governance.

Qualifications

Dr. Butcher is the holder of a Doctorate in Business Administration (Magna cum Laude) and has served on a number of Boards, both locally and internationally. She was commended by the Inter-American Development Bank for leading the most successful education project in the Caribbean region during the period 1996 to 2001. Dr. Butcher transformed this project into a leading Hospitality and Tourism Institute in the Caribbean, which she successfully steered for over 20 years; copping several national awards and regional recognition.

Netball Experience

As an Executive member of the All Sectors Netball League in the Republic of Trinidad and Tobago for the past twenty four (24) years she has contributed to the continued success of this league, which has resulted in employment opportunities for many national netballers.

In addition, she has held the position of President of the Trinidad and Tobago Netball Association (TTNA) for three (3) terms. Under Dr. Butcher's leadership, the TTNA was awarded the prestigious First Citizen's Bank Sport Administration Award for the first time in the TTNA's 70-year history from among sixty (60) associations.

She has also served as President of the Americas Federation of Netball Associations (AFNA) for the period 2015 to 2018 and has played an integral part in the development of strategic plans over two terms. TTNA has also benefited from her leadership in this regard. INF is due to revisit its current strategic plan and can benefit from Dr. Butcher's wealth of experience in this area.

Corporate Governance, Coaching development, Umpire development, the expansion of the sport in the Americas region with particular attention on South

America and the establishment of Board Committees were areas of focus during her tenure as President of AFNA. She has also influenced greater collaboration between the Caribbean Netball Association (CNA) and AFNA through combined membership on the AFNA Tournament Committee. An inaugural High School Tournament was held in Jamaica in 2018.

In order to maintain the integrity of the administration of the sport, Dr. Butcher intends to recommend for consideration the introduction of independent non-executive Board members with specific expertise on member boards. This feature has already been introduced under Dr. Butcher's tenure as President of TTNA.

She has held the position of Regional Director for the Americas region on the Board of the International Netball Federation (INF) for the past four (4) years and chairs the Commercial Committee on the INF Board. From a succession planning perspective, Dr. Butcher is well-placed to ensure the seamless continuation and expansion of the plans for the development of netball. Having worked under the chairmanship of Honourable Molly Rhone OJ CD, Dr. Butcher looks forward to continuing Molly's legacy, which has been established over four (4) terms.

Her fifteen (15) year experience in the airline industry at managerial and executive levels resulted in her extensive travel and brought her into contact with executives across the globe. As Director of Inflight Services at BWIA International, she was able to influence policy and provide strategic direction as a board member of the International Inflight Management Organization.

She lectured at the undergraduate and graduate levels in the areas of Management of Quality, Strategic Planning and Services Marketing and continues to share her knowledge and experience as a guest lecturer at the MBA level at tertiary institutions from time to time.

Vision

Should Dr. Butcher be given the opportunity to lead the INF, her vision is to influence an increase in the popularity of the sport via viewership, sponsorship and spectatorship through

- ensuring premier league competitions in every region across the globe;
- greater involvement of men playing the sport; and

This would be a tremendous tool for coaches with respect to improving knowledge of the game. Football continues to benefit from the *Fifa* animated game in this regard.

Dr. Butcher's focus and priorities for the INF aim to increase revenue generation toward the development and sustainability of the sport. She looks forward to engaging the members in discussions that would assist in innovating and improving the brand toward the achievement of becoming a premier sport in the global arena.

Played a leading role in the progression of Netball in England for 16 years before taking on the challenge of driving the development of the UK High Performance system over a 20-year period, achieving extraordinary success at successive Olympic and Paralympic Games with Team GB finishing 2nd in both medal tables in Rio 2016.



Leadership experience also extends to Major Events and International Relations through UK Sport's support for the bidding and hosting of Major Events in the UK to showcase success and increase engagement while ensuring the UK has a strong, supportive and respected voice in international sport.

Candidacy for the role of President of the International Netball Federation

I write to confirm my willingness to be nominated for the position of President of INF and to explain my reasons.

Netball has been a big part of my life from a very young age. It gave me invaluable opportunities to develop my leadership skills in a safe and supportive environment. I cherish my years as a Netball player in school, in university, for my county, region and nation, Wales, and especially the amazing opportunity I had to play in two World Cups in New Zealand in 1975 and in Trinidad in 1979.

I also feel a debt of gratitude to a previous President of the INF, Pat Taylor MBE, who as Chair of England Netball gave me the chance to be CEO of England Netball from the age of 27. It was a brave decision. Even when I resigned just over two years later to take four years out of work to raise my two children, England Netball welcomed me back and I enjoyed just under 14 further years in the role. In that time, I saw the sport improve performance, increase participation while increasing the quality of its support. I was also privileged to be entrusted with the role of Championship Director of the World Netball Championships 1995 held in Birmingham and to experience Netball featuring in its first Commonwealth Games in 1998 when the England team won the bronze medal.

Together, these experiences positioned me as a credible candidate in 1999 for the role of Director of Performance at UK Sport. UK Sport is a public body accountable to Government and responsible for Inspiring the Nation by driving and showcasing medal success. From the Sydney 2000 Games, I learnt very quickly about Olympic and Paralympic sport and what it takes to win. I moved up through the organisation as Director of Performance/ Elite Sport, Chief Operating Officer and then Chief Executive from 2010 with the privilege of leading the organisation through the home Olympic and Paralympic Games in London 2012, through Rio 2016 and the Winter Games in between and now through three of the four years towards Tokyo 2020. I am stepping down from early July 2019 to enable my successor to the lead the organisation through the Tokyo Games and take ownership of the strategy for the next four years cycle. It is the right thing to do.

Over that time the responsibilities of UK Sport, not only for Performance, but also for Major Events, International Relations and Governance, have broadened my knowledge of the national and international sporting landscape and its diverse challenges.

I will look back with confidence and with pride that I have played a significant part in the transformation that has created one of the world's leading high performance systems. The UK has been truly inspired and has celebrated an amazing journey of success over nearly 20 years.

As I step down from my role with UK Sport this summer, I feel drawn back to the sport that helped me become who I am today. I feel a responsibility to 'give back' to give others the opportunity to develop as I did through Netball and I know that I now have a broader experience and perspective to share.

2. STATEMENT FROM LIZ NICHOLL

I appreciate that Netball has moved on over the last 20 years with a growth in countries in membership and in numbers playing, coaching and officiating. I have had the opportunity to see some of this over the years through UK Sport's long-standing partnership with INF to develop the sport in Africa and my visits to countries such as Zambia where the growth and power of netball to engage girls and young women has been inspirational to see. At the elite level I can see that the opportunities for athletes to play in national and international leagues has also increased and, as a consequence, so too have skill levels and attractiveness to new audiences.

Recently I visited Argentina on UK Sport business and had the opportunity to meet with representatives from Argentina Netball leading on the NET2019 international development initiative. I was curious to learn how Netball could be introduced in a country where it is unknown. The commitment, determination and energy of the volunteers was tangible and with a workforce like this, anything is possible. I have no doubt there are plenty of similar examples that I have yet to learn about – and this amazing potential is drawing me back to Netball.

I have huge respect for the progress of INF under Molly Rhone's leadership. When I travel internationally in my UK Sport role I always find and take every opportunity to mention that Netball is 'my' sport. When I do so, it is often followed by words of fondness, respect and admiration for Molly and the progress of INF and the sport. If I were to be elected as your President, I would want to build on Molly's tremendous legacy to take the sport to its next level in terms of its leadership, impact and relevance to a wider audience while increasing its resources and partnerships to drive its growth and potential.

Through my candidacy, I offer my services to the sport I love.

Injury to one of the major stabilisers of the knee, the Anterior Cruciate Ligament (ACL), is a common problem, annually representing approximately 25% of serious injuries (Netball Australia National Insurance Data).

Netball Australia's KNEE Program is designed to prevent these injuries occurring.
