5 APPROVAL OF MINUTES OF CONGRESS HELD GABORONE 6th & 7th JULY 2017

A motion to approve the minutes from Congress 2017, held in Gaborone was proposed by Australia, seconded by New Zealand and unanimously approved.

PRESIDENT'S ADDRESS

The INF Vice President, on behalf of the Board of the International Netball Federation, extended a warm welcome to all valued Members joining them at Congress, and particularly to those who were attending for the first time.

The Vice President formally introduced the Board.

The President's address is shown in full in Appendix 2.

8 BOARD REPORT

The CEO presented the Board report which explained the progress against the key performance indicators identified in the INF Strategic Plan Netball 2020, the Vision, Mission and Values set out by the INF Board for the sport.

8.1 The CEO directed members towards the Annual Report for 2018 and the Annual Report and Accounts for 2017 for more detail on progress made in those two years.

Members were informed of the work being undertaken by INF in 2019. The CEO highlighted that the strategic planning for beyond 2020 was ongoing and would be developed further by the Board during the remainder of 2019.

9.0 FINANCIAL REPORTS AND REPORTS FROM FINANCE DIRECTOR

9.1 Members were given a short presentation highlighting the major features of the INF financial statements for 2017 and 2018

The Finance Director explained the reliance on income from INF Events especially Netball World Cup over the 4-year cycle. It was noted that the cyclical nature of INF finances had resulted in deficits of £323k and £345k in 2017 and 2018 respectively.

It was noted that Income from subscription fees was the most important source of income for INF in both 2017 and 2018.

Members were given a breakdown of INF expenditure for 2017 and 2018 which outlined the split of expenditure across INFs three strategic pillars.

- **9.2** The Finance Director informed members that the INF Board had approved the financial statements for 2017 and 2018 and requested that INF Congress receive and note the Financial Statements and Annual Report for 2017 and 2018.
- **9.3** Members were informed that during 2018, the Audit and Risk Committee had assessed audit quality and recommended that Beever and Struthers continue as INF auditor. The INF Board had accepted the recommendation and had appointed Beever and Struthers as auditor for 2019.

10 NETBALL WORLD YOUTH CUP 2021

Wainikiti Bogidrau of Netball Fiji addressed Congress, thanking the INF board for the opportunity to present.

Members were given an update of improvements being made to current facilities and the confirmed Organising Committee structure and were informed that the tournament would take place 10th to 19th June 2021.

The USA raised concerns that the proposed date may clash with the academic calendar in some countries. Fiji accepted that this may be an issue however felt that this may be an issue for other regions were the date to move. Fiji explained that the advantage of holding the event in June is that student accommodation would be available at this time and this would reduce the costs for participating teams.

Canada questioned whether the facilities in Fiji would be air conditioned and it was explained that as June is wintertime in Fiji it is probable that full air-conditioning would not be required.

11 NETBALL WORLD CUP 2023

Mokoditloa Eliakim Moemi, Sport and Recreation Director General. RSA introduced a short video presenting the outline plans for the Netball World Cup in Cape Town South Africa in 2023 and invited Members to attend NWC2023 and the 2023 INF Congress that will run alongside the event.

Cook Island questioned whether any arrangements are being made in respect of visas from travel to NWC2023. Mr Moemi stated that the new government in South Africa was looking at ways to ease travel to South Africa for the event and that it had already agreed that visas would not be required for Congress delegates.

Antigua and Barbuda questioned whether vaccinations would be required and was informed that South Africa subscribes to WHO rules in respect of vaccinations.

Nathi Mthethwa Minister for Sports Education and Culture. RSA, echoed the invitation to Cape Town in 2023 and gave his full commitment to supporting the event.

12 LAUNCH OF NWYC2025 AND NWC2027 BIDDING PROCESS

The CEO opened the call for 'Expressions of Interest' to Host the Netball World Youth Cup 2025 and Netball World Cup 2027.

Members were reminded that to bid you must be a Full Member of INF.

The INF has decided to provide Members and their partners with a longer window to prepare for the delivery of the NWC. This will provide more planning time and greater

certainty for INF and host countries. It may also provide opportunities for Members to gain the support of their funders (governments and host cities) ahead of them making commitments to other sports.

INF will therefore be running the bidding process for the NWYC2025 and NWC2027 at the same time.

Key Deadlines

- Expressions of Interest (EOI) must be submitted in writing by 31st December 2019.
- The Bid Application Documents will be circulated by 15th November 2019.
- Full Bids must be received by INF by 31st March 2020.
- A full Bid Evaluation will be carried out from 1st April 31st September 2020
- Hosts announced by year end 2020

Members were encouraged to contact the CEO for further information and guidance.

Congress adjourned for lunch at 12:45pm and reconvened at 14:00pm.

13 INF GOVERNANCE AND ARTICLES OF ASSOCIATION

Roland Jack from iTrust Sport gave a presentation entitled "Governing with integrity for the future of Netball" The presentation looked at why governance matters for sport e.g. History of scandals – public concern and stated that loss of trust in all areas of society means that Improvements in governance give an organisation such as INF the best chance of achieving its objectives.

Mr Jack outlined the INFs performance in respect of governance as follows:

- Benchmarking INF 2017 findings: Solid and consistent standards, recommendations: update electoral rules, Increase transparency of information.
- Benchmarking INF 2018-19 findings: Ranking 2nd out of 54, Key findings consistent, high level of transparency, recommendations – Establish an Athletes' Committee

Congress was then given an insight into the current trends in sports governance these being;

- Increasing transparency
- Term limits for Directors and Committee Members
- Focus on safeguarding
- Demonstrating benefits of an IF compared with private event organisers
- The importance of Independent committee members / directors
- Attention on organisational culture

The presentation concluded with members being asked to see improvements in governance as an opportunity and Members were reminded that with these improvements, netball can be world class and we can make the most of our limited resources.

ARTICLES OF ASSOCIATION

Members were informed that in order to make improvements to INF Governance several changes to the Articles of Association were being proposed by the Board. These changes fell into the following three categories Membership, Congress and the

Board review and changes to make the articles gender neutral. The agreed changes are shown in full at Appendix 3.

Membership

Articles 3.1 and 3.1.1. Members requested clarification as to why this change was needed and it was explained that although countries had in the past, been allowed to have more than one Associate member of INF (e.g. UAE) this was no longer appropriate and should be amended to ensure only one members per country. The proposal was approved.

Article 3.2.2 Congress was informed that the current Articles of Association have no specific provision regarding membership requirements for Associate Members and that the proposed amendment to 3.2.2 would resolve this. The membership requested that the word 'claim' in 3.2.2 (c) be amended to read 'hold'. The revised proposal was approved.

Article 3.5.2. Congress was informed that the current Articles of Association have no specific provision regarding readmission for suspended Members and that the addition of 3.5.2 would resolve this. The proposal was approved.

Article 3.5.4. Congress was informed that the current Articles of Association have no specific provision to reflect the change made on 2019 regarding the fee structure for Associate Members and that the proposed addition of to 3.5.4 (c) would resolve this. The proposal was approved.

Congress

Article 5.1.2. It was explained that one of the findings highlighted in governance reviews of INF undertaken in 2017 and 2019 was that the INF Board would benefit from the addition of one or more Independent Directors. The INF board had looked closely at this and felt that a proposal should be put before Congress that would see two of the current Director roles move from being elected roles to appointed roles through a Nominations Committee. The Board proposed that these roles should be that of Vice President and Further Director. Congress felt very strongly that the Vice President should be elected by the Membership and an amendment was proposed by Fiji to make the Finance Director role an Independent Director rather than the Vice President role. Feeling was split as to whether the Finance Director and Further Director posts should be appointed, and the amendment was voted on and not carried. Following further discussion and sharing of experiences Netball Australia proposed an amendment that only the Further Director post should be appointed. The amendment was voted on and carried and the article as amended was approved.

Board

Article 6.1.1 Would change as a consequence of changes to 5.1.2. The article as amended was approved.

Article 6.1.4 The Board proposed removing the maximum timeframe for questions to election nominees to give discretion to the chair (so that they can ensure fairness and equity). The proposal was approved.

Article 6.1.5 Would change as a consequence of changes to 5.1.2. The article as amended was approved.

Article 6.1.7. Would change as a consequence of changes to 5.1.2. The appointment of an Independent Director would be managed by a Nominations Committee. Congress was informed that the Nominations Committee would include a representative of the membership and a specialist in Governance/Board appointments. The article as amended was approved.

Article 6.1.10. The independent review of INF governance recommended that the provision for exceptional circumstances be removed in respect of Board term limits as it provided the potential for the Board to not comply fully with the intention of the article. Congress was informed that the amendment to 6.1.10 would resolve this. The proposal was approved.

Article 6.1.11 Congress was informed that article 6.1.11 is now obsolete and therefore no longer required. The proposal was approved.

Definitions

Consequential changes to definitions would be required in light of the changes to the Articles of Associations that had been approved.

General

The Articles of Association would be amended throughout to ensure gender neutrality.

Congress agreed that given the time overrun item 14, 15 & 16 would be deferred to the first items of business on Day 2.

17 ELECTION OF OFFICERS

17.1 Finance Director

There was one candidate for the position of Finance Director:

• Ann Tod - Nominated by New Zealand Seconded by Australia

The Vice President invited Ann Tod to address Congress.

A motion to re-elect the Finance Director without the need for a vote was proposed by Australia and seconded by Wales. The motion was approved.

Ann Tod was re-elected as Finance Director unopposed, for 4 years until the end of NWC2023.

President

There were two candidates for the position of President:

- Dr Patricia Butcher Nominated by Trinidad & Tobago and Seconded by Grenada
- Liz Nicholl CBE Nominated by England Netball and Seconded by Netball New Zealand

Each candidate was invited to address Congress.

Liz Nicholl was elected President by secret ballot and she would take up her position on the INF Board at the end of the NWYC2019, as per the Articles of Association, for a 4-year term until the end of NWC2023.

Liz Nicholl thanked Congress for being voted as President.

A motion was requested to destroy the voting slips. Barbados moved the motion, and Fiji seconded the motion.

The meeting adjourned at 17:30pm.

Congress reconvened at 8.30am on 11th July.

18 GOVERNANCE IN ACTION

Caroline Barker, Sports journalist introduced this session which comprised of 2 panel discussion followed by an interview with Sharni Layton ex Australian Diamond.

In the first panel session that looked at player and participant welfare and wellbeing, Julie Harrington, British Cycling and Malebo Raditladi shared their experiences highlighting the role of governance in tackling bullying behaviours and discrimination and the SafeSport programme that was in place at NWYC 2017.

The second panel session looked at injury prevention in Netball. Kate Agnew, Netball New Zealand gave Congress an insight into the Netball Smart Programme currently in use in New Zealand and Alanna Ancliff, Netball Australia gave an overview of The Knee Programme (prevention of knee injury in netball) currently in place in Australia.

In her interview Sharni Layton gave Congress a personal perspective on the pressures faced by elite athletes and netballers in particular she emphasised the need for good psychological support around athletes and the need for breaks during the season and between domestic and international seasons to ensure that athletes have the space to manage their mental health.
