WORLD NETBALL - Director (2011-2015)

Australia won the right to host the 2015 Netball World Cup. Serving on the World Netball Board provided an opportunity for me to identify other ways in which benefits from NWC2015 could be maximised for World Netball and member Federations.

The honour of serving and contributing to the future of netball globally had a profound impact on me. It provided an opportunity to meet and share ideas with like-minded people from around the world and to make decisions with an understanding and respect for the differences and more often common experiences of netball organisations and participants globally.

ASIAN NETBALL REGION – Delegate

As an Asian Regional Director, I had the unique opportunity to learn more about the opportunities and challenges facing younger nations to grow netball and contributed and added value where possible. The key reflection is that it is important to acknowledge the rich netball history in all Federations and respect their importance to the future of the sport.

NETBALL AUSTRALIA – Chief Executive 2007-2017

Netball Australia is the National Sporting Organisation responsible for the governance, development and promotion of netball throughout Australia. Over 1.2 million participants enjoy the game nationally and Australia has been dominant on the international stage since 1963. Netball in Australia has more than 350,000 registered members based in eight member organisations. The sport provides pathways for athletes, coaches, umpires and administrators that nON by a range of development programs and services. Key Responsibilities:

Reporting to the Chair of the Board, the role was responsible for: modernising the organisation; uniting and bringing the sport together nationally; professionalising the sport; increasing the national and international profile, as well as increasing revenue through partnerships and sponsorships. This included oversight of four direct reports, forty-nine employees and a budget of \$20million.

NETBALL VICTORIA - Chief Executive 2000-2006

Netball Victoria is a non-for-profit organisation responsible for the management and development of netball across Victoria. With over 120,000 members, the organisation's core function is to identify and meet the needs of netball players, coaches, umpires, administrators, associations and clubs and in doing so enhance participation experiences and encourage participation in the sport.

Key Responsibilities:

Reporting to the Chair of the Board, the role was responsible for continuous business improvement, modernising and strengthening the position of the organisation, as well as growing revenues. This included oversight of five direct reports, twenty-six employees, thousands of volunteers and a budget of \$5.5million.

NETBALL EXPERIENCES - BROADLY

Prior to becoming Chief Executive of Netball Victoria, I was the Administration Manager from 1995 to 1998 and the Junior Development Manager from 1994 to 1995.

A lifelong involvement in netball as an Athlete at many levels (community, regional and State) as an Umpire to the Australian 'B' grade standard (not current), a Team Manager at the Victorian State underage and open level, a Coach at the community level, a netball commentator for TV and radio and a volunteer committee member at the local level.

OTHER BOARD and COMMITTEE APPOINTMENTS

Director – Richmond Football Club (Feb 2021 – current)

The Richmond Football Club's (RFC) Purpose is "Connecting to Thrive and Win". The RFC competes in the Australian Football League (AFL). With over 100,000 members, the Club prides itself on continuing to build a "strong and bold" future. The Club was formed in 1885 and has won 13 Premierships in the history of the VFL/AFL competition, including recent successes in 2017, 2019 and 2020. Punt Road Oval has been the home of the Richmond Football Club since the Club's inception in 1885 and recently the Board approved plans for a major redevelopment to deliver a state-of-the-art training facility and elite training ground for its AFL, AFLW and VFL teams. The Centre will remain the home to both the Administration and Football departments of the Club, as well as the Korin Gamadji Institute and Bachar Houli Foundation.

Director – Canteen Australia (Sept 2020-2023)

Canteen Australia provides tailored support for young people aged 12-25 who are impacted by cancer. All support services are underpinned by Canteen's research and evaluation team who conduct world-class psychosocial research with the goal of transforming the lives of young people affected by cancer.

I was actively involved in a capital raising campaign, to deliver two cancer hubs (Sydney and Melbourne), in collaboration with Camp Quality and Red Kite that will streamline the way that 74,000 children, young people and their parents impacted by cancer receive the support they need.

Chair – Victorian Institute of Sport (VIS) (2010-2016)

This appointment coincided with a disruptive time in the VIS history. The VIS they were being relocated to a redeveloped site at Albert Park. The organisation was reluctant to move from their home of ten years. As Chair, the role was to focus the organisation on the move and how we could achieve the same or improved infrastructure, equipment, conditions of lease. This was achieved and shifted the emphasis to embracing the new home. In addition, the focus was on leading, via the Board, a new strategic framework (to integrate Australia's Winning Edge strategy) and exploring how to create financial sustainability in a resource tight environment.

Trustee – Melbourne Cricket Ground Trust (2004-2015)

Appointed initially by Justin Madden (and reappointed twice).

Trustee during the \$400m MCG redevelopment in preparation for the Commonwealth Games (2006). Represented the Trust on a range of sub-committees including:

- a. Great Southern Stand Steering Committee a \$55m project to refurbish facilities.
- b. Water Recycling Project \$24million project to build Victoria's largest underground water recycling facility. The water plant treats sewerage from the local network to Class A recycled water standards. More than 189 million litres of recycled water are produced each year reducing the MCC use of potable water by 50%. An important initiative to meet the MCC/Trust environmental sustainability objectives.
- c. Australian Sports Museum A \$25million dollar project to revamp the National Sports Museum in 2007/8. The redevelopment was critical to modernise the ground infrastructure and ensure that the people of Victoria and Australia had access to the most significant Australian collection of sporting heritage. It was also important to increase entertainment experience for the growing number of international visitors to the MCG.

Member - Australian Sports Anti-Doping Authority (ASADA) Advisory Group (2010 - 2014)

Appointed by the Commonwealth Government

The ASADA Advisory Group was established in May 2011 to act as an advisory forum for ASADA's CEO on anti-doping matters. They also provided advice more broadly on matters relating to engagement with sporting bodies and providing one-on-one advice to the CEO in specific areas relating to the individual member's area of expertise. The group comprised experts in sport, health, law and law enforcement. The 'blackest day in Australian sport' occurred during this tenure and although the Advisory Group was not actively involved, and had no delegated powers relating to the matter, we were exposed to insights into actions/responses of government, NSO and athletes during an unprecedented crisis.

The ASC is governed by a Board of Commissioners appointed by the Minister for Sport and unites two entities: Sport Australia (SA) – responsible for increasing participation, physical activity and industry growth across the broader sports sector; and the Australian Institute of Sport (AIS) – leading Australia's high-performance sports sector. The ASC vision is for Australia to be the worlds' most active sporting nation, known for its integrity, sporting success and world-leading sports industry.

Key Responsibilities:

Reporting to the Chair of the Board, and responsible to the Office for Sport (Secretary - Department of Health) and the Commonwealth Minister for Sport, the role was responsible for delivering on government Policy to strengthen the sport industry in Australia, increase participation rates, achieve sporting excellence in high performance, and ensure the integrity of the sector. This included oversight of 420 people, with four direct reports, a 65-hectare AIS site with 38 buildings and venues, restaurants/cafes, gym, childcare and swim centre (5-star venue) and a budget of \$300million.
