2.2 QUORUM

A quorum was present and confirmed. The total number of Full Members in attendance including proxy votes was 49.

3. HONOURING THE DEPARTED

Congress honoured the departed with a moment's silence. The honoured departed are noted in Appendix 1.

4. VOTING PROCEDURE & THE INDEPENDENT SCRUTINEER

Optivote, who were contracted by World Netball to provide the voting system, acted as the independent scrutineer. Luke Ziegenhardt, a representative from Optivote explained the voting procedure and invited voting delegates of the Full Member Countries to undertake a practice of the voting system.

5. APPROVAL OF MINUTES OF THE SPECIAL MEETING OF CONGRESS 29th JANUARY 2022

A copy of the minutes had been circulated to Members. Comments had been received: mainly grammar and spelling and relevant amendments made.

An Ordinary Resolution of the Members means a resolution that is passed by a simple majority i.e. more than 50% of those voting.

Ordinary Resolution: Do Members accept the Minutes of the Special Meeting of Congress held on Saturday 29th January 2022 as a true record of the meeting?

Available vote: of the 49 Members in attendance who voted, 34 voted in favour of the resolution, therefore this resolution was approved by 70% of the available vote.



6. MATTERS ARISING

7. PRESIDENT'S ADDRESS

BOARD REPORT

The CEO presented the activities of World Netball with reference to the 2021 and 2022 Annual Reports.

9. FINANCIAL REPORT

The Finance Director presented an overview of the finances of the Federation referencing the 2021 and 2022 Annual Financial Statements.

The Finance Director informed Congress of the process for appointing the Auditors and advised that Beever and Struthers, Chartered Accountants had been appointed for 2023.

10. PROPOSED RULES CHANGES

The Rules Advisory Panel presented the principles underpinning its proposed rules changes.

A discussion was had regarding two of the proposed rules amendments (Short pass and toss up). agreed that the rules be passed with the exception of 8.5 Toss Up and 9.5.1 Short-Pass.

A Special Resolution of the Members means a resolution that is passed by at least 75% of those voting.

Special Resolution: Do Members accept the rule changes proposed by RAP?

Available vote: of the 49 Members in attendance who voted, 25 voted in favour of the resolution, therefore this resolution was not approved as only 57% of the available vote.

Netball New Zealand proposed an amended resolution, seconded by Netball Australia.

Special Resolution: Do Members accept the rule changes proposed by RAP except for rules 8.5 and 9.1.a?

Available vote: of the 49 Members in attendance who voted, 37 voted in favour of the resolution, therefore **this resolution was approved by 76% of the available vote**.

It was agreed that a meeting would be convened at 19.30 that day to discuss the wording of the two excepted rules. If agreement can be reached, then a resolution to accept the two excluded rules would be brought to Congress the following day.



11. BUSINESS FROM MEMBERS FOR WHICH DUE NOTICE WAS GIVEN

St Lucia took the floor to raise the issue of the development of a WN Technical Development Manual.

President introduced Dr Anita Navin Chair of CAP and Garrett Williamson Chair of OAP to discuss the work ongoing in this area.

Zimbabwe took the floor to raise the issue of increasing of the international squad size to 15 players.

President explained that options continue to be discussed at Board level but would appreciate Congress's view. President proposed a straw poll as follows:

Vote: Do you believe that World Netball should invest resources to investigate the increase of international squad size to 15 players?

Available vote: of the 49 Members in attendance who voted, 26 (53%) voted in favour of World Netball investing its resources to investigate this issue.

12. APPLICATIONS FOR MEMBERSHIP

Applications for Full Membership of World Netball have been received from Netball Guadeloupe and British Virgin Islands Netball Association. World Netball Secretariat confirmed that Netball Guadeloupe and British Virgin Islands Netball Association have fulfilled all the compliance requirements associated with Full Member Applications. Both Guadeloupe and British Virgin Islands are situated in the Southern Caribbean Sea and are Members of Americas Netball.

A Special Resolution of the Members means a resolution that is passed by at least 75% of those voting.

Special Resolution: Do Members accept Netball Guadeloupe as a Full Member?

Available vote: of the 49 Members in attendance who voted, 45 voted in favour of the resolution, therefore this resolution was approved by 92% of the available vote.

Special Resolution: Do Members accept British Virgin Islands Netball as a Full Member?

Available vote: of the 49 Members in attendance who voted, 46 voted in favour of the resolution, therefore **this resolution was approved by 94% of the available vote**.

Applications for Full Membership of World Netball had been received from Netball Burundi and Solomon Islands Netball. World Netball Secretariat confirms that Netball Burundi and Solomon Islands Netball have fulfilled all the compliance requirements associated with Full Member Applications.

Special Resolution: Do Members accept Netball Burundi as a Full Member (currently Associate)?

Available vote: of the 49 Members in attendance who voted, 46 voted in favour of the resolution, therefore this resolution was approved by 94% of the available vote.

Special Resolution: Do Members accept Solomon Islands Netball as a Full Member (currently Associate)?

Available vote: of the 49 Members in attendance who voted 46 voted in favour of the resolution, therefore this resolution was approved by 94% of the available vote.

13. ELECTION OF OFFICERS

Congress was informed that the President's initial four-year term has come to an end and that an Election for World Netball President is required.

Dame Elizabeth (Liz) Nicholl was the only candidate nominated for President by the due date. Nominated by Wales and seconded by Hong Kong. Congress was requested to formally resolve to approve the appointment of Liz Nicholl for a further four-year term of office as President.

An Ordinary Resolution of the Members means a resolution that is passed by a simple majority i.e. more than 50% of those voting.

Ordinary Resolution: That Congress elects Dame Elizabeth Nicholl as World Netball

President for a second term?

Proposer: Wales

Seconder: Hong Kong

Available vote: of the 49 Members in attendance who voted, 45 voted in favour of the resolution, therefore this resolution was approved by 92% of the available vote.

Liz acknowledged the vote and thanked the Delegates for their support.

Congress was informed that following Regional Directors have been elected by their Regional Federations to serve on the World Netball Board for a four-year term commencing 7th August:

- Americas Dr Bridget Adams (Marva Barnard OD has reached her maximum term on the Board so was stepping down).
- Asia Victoria Lakshmi (replacing Gaby Hochbaum who decided to step down from her role).
- Europe Lyn Carpenter.
- Oceania Wainikiti (Kiti) Bogidrau.

Africa Netball will be holding their AGM and elections later in 2023.

14. APPOINTMENT OF OFFICERS

Congress was reminded that Ann Tod would be retiring as finance director with effect 7th August 2023 and that during 2022, members had overwhelmingly voted that following the

end of her tenure, the elected Finance Director role be converted to an Independent Finance Director Role which would be recruited by Nominations Committee and appointed by Congress.

Members were also reminded that in a groundbreaking move Congress had voted to establish the role of Athlete Director, which whilst in the future would be a role elected by Athletes, in the first instance this would be recruited by Nominations Committee and appointed by Congress.

Following a comprehensive recruitment process Suri Bartlett was proposed by the World Netball Board for the role of Independent Finance Director. Congress was requested to formally resolve to approve the appointment of Suri for a four-year term of office as Independent Finance Director.

Suri Bartlett spoke for a few minutes to introduce himself to members.

An Ordinary Resolution of the Members means a resolution that is passed by a simple majority i.e. more than 50% of those voting.

Ordinary Resolution: That Congress appoints Suri Bartlett as the Independent Finance Director for an initial four-year term?

Available vote: of the 49 Members in attendance who voted, 45 voted in favour of the resolution, therefore this resolution was approved by 92% of the available vote.

In a separate but equally rigorous process Stacey Francis-Bayman was proposed by the World Netball Board for the role of Athlete Director. Congress was requested to formally resolve to approve the appointment of Stacey for a four-year term of office as Athlete Director.

Stacey Francis-Bayman spoke for a few minutes to introduce herself to members.

Ordinary Resolution: That Congress appoints of Stacey Francis-Bayman as the Athlete Director for an initial four-year term?

An Ordinary Resolution of the Members means a resolution that is passed by a simple majority i.e. more than 50% of those voting.

Available vote: of the 49 Members in attendance who voted, 46 voted in favour of the resolution, therefore this resolution was approved by 94% of the available vote.

Suri and Stacy acknowledged the vote and thanked the Delegates for their support.

15. ELECTION OF COMMITTEE MEMBER REPRESENTATIVE

Congress was informed that Catherine Lewis' initial four-year term as Member representative on the World Netball Nominations Committee has come to an end and that an Election for a Member representative was required. Catherine was the only candidate nominated for the role by the due date. Congress was requested to formally resolve to

10. PROPOSED RULES CHANGES (part 2)

Following a well-attended meeting the evening before, the Rules Advisory Panel presented amended changes for 8.5 Toss Up and 9.5.1 Short-Pass. Furthermore, it was agreed that the amended short pass rule would be subject to a 12 month trial period.

A Special Resolution of the Members means a resolution that is passed by at least 75% of those voting.

Special Resolution: Do Members accept the amended rule changes 8.5 Toss Up and 9.5.1 Short-Pass proposed by RAP?

Available vote: of the 49 Members in attendance who voted, 42 voted in favour of the resolution, therefore **this resolution was approved by 86% of the available vote**.

19. NETBALL WORLD CUP 2023

Cecilia Molokwane, Director NWC2023 Organising Committee shared an update of NWC2023 and invited all Congress attendees to a dinner that evening at the CTICC Ballroom.

20. NETBALL WORLD YOUTH CUP 2025

22. BIDDING PROCESS FOR NWYC2029 AND NWC2031

The CEO provided an outline and timetable for the bidding process for NWYC2029 and NWC2031. The process for bidding would be issued in the near future.

23. KEYNOTE SPEAKERS - THE UNSTOPPABLE RISE OF WOMEN'S SPORT

A video from the Hon. Kirsty Leigh Coventry Seward, Minister of Youth, Sport, Arts and Recreation in Zimbabwe, discussing her experience of the unstoppable rise of women's sport, was shared with Congress.

A round table discussion on the topic then took place between

- Caroline Barker, British sports journalist, and broadcaster;
- Vanes Maria Du Toit, South African broadcaster and;
- Stacey Francis-Bayman, retired England Rosel and Athlete Director for World Netball.



24. ANY OTHER BUSINESS

Members were informed of the timetable for World Netball's Congress Workshops.

25. PROPOSED DATE AND LOCATION OF CONGRESS 2023

It was confirmed Congress 2025 would be held on 17-18 September 2025 in Gibraltar.

The President thanked all Members for attending and the meeting of Congress ended.
