

Rules Advisory Panel (RAP) Application Process 2025

Background

The Panel is responsible for advising the Chief Executive and the Board of World Netball (WN) and working with them to support the development and implementation of agreed priorities in the Strategic Plan, particularly, in relation to the control and review of the Netball Rules and their application. The Terms of Reference are attached.

Panel Responsibilities

In relation to International Netball the panel will:

- Undertake regular reviews of the Rules of Netball, reviewing proposals to change the rules and proposing changes to the rules for all approved formats of the sport.
- Oversee the implementation of rules internationally to ensure consistency of application.
- Consider requests for interpretation of the Rules submitted to WN.
- Advise WN on proposed exemptions or variations of rules
- Maintain rules interpretations and FAQs.
- Prepare rules guidelines and articles.
- Authorise and monitor rules trials as required.
- Prepare education and training resources to support the implementation of the rules
- Provide input to all WN manuals as appropriate.
- Attend WN events to provide observations on the application and interpretation of the rules.
- Attend WN umpiring and coaching conferences and meetings.
- Contribute to WN's Play strategy.
- Work in conjunction with other Committees and Panels in the broader context of WN's strategic development objectives.

- b) Proven organisational skills;
- c) Ability to think and plan strategically;
- d) Sound knowledge of the rules of netball;
- e) Demonstrable understanding of performance level netball;



- f) Ability to bring a global perspective;

- h) Ability to work collaboratively;
- i) Effective communicator;
- j) Willingness and ability to travel;
- k) Commitment to WN values¹

Applications are invited from suitably qualified individuals to join WN in the role of WN Rules Advisory Panel member.
